RE: Addendum to Memorandum on “Oversight Committee Democrats Push Anti-Trump Hoax Instead of Pursuing Justice for Epstein Victims”

I. Overview

On November 16, 2025, the Republican staff of the House Committee on Oversight and Government Reform issued a memorandum titled “[Oversight Committee Democrats Push Anti-Trump Hoax Instead of Pursuing Justice for Epstein Victims](#).” Since then, Democrats have continued to beclown themselves by sensationalizing and politicizing the Committee’s review of the federal government’s investigation into Jeffrey Epstein and Ghislaine Maxwell—an effort intended to ensure accountability, transparency, and justice for the American people and the survivors of their horrific crimes. To recap:

- **Democrats lied about former U.S. Attorney General William Barr’s [deposition](#)**, falsely claiming he did not exonerate President Donald Trump. In fact, Barr stated clearly that there was no evidence linking President Trump to Epstein’s criminal activity.
- **Former U.S. Attorney for the Southern District of Florida and former Secretary of Labor Alexander Acosta** dismantled Democrats’ Trump-Epstein smear during his [transcribed interview](#), confirming there was no contact between President Trump and Acosta and no connection between Trump and Epstein in the case.
- **Democrats [selectively leaked three emails](#)** from more than 20,000 pages of documents produced by the Epstein Estate and applied their own redactions to manufacture an anti-Trump narrative and mislead the media and the public. When CNN questioned the redactions, Democrat Committee members falsely claimed Republicans were responsible. After Republicans released more than 20,000 pages, Democrats then [claimed](#) this transparency was intended to “disorient” and “distract” from their fabricated narrative.
- **Democrats conspicuously withheld other relevant facts**, including that Rep. Stacey Plaskett (D-U.S. Virgin Islands) [texted](#) Jeffrey Epstein during a 2019 congressional hearing to solicit advice on questioning a discredited witness with a vendetta against President Trump. They also did not disclose an [email](#) in which the campaign of Minority Leader Hakeem Jeffries (D-N.Y.) solicited a donation from Epstein.

This is an addendum to the November 16, 2025 memorandum.

II. Democrats Redact Adult Women's Faces to Spread Hoax About President Trump

On the evening of December 11, 2025, the House Committee on Oversight and Government Reform received 95,000 photos from the Epstein estate. The very next morning, on December 12, 2025, Oversight Committee Democrats posted 19 photos at 10:14 a.m. ET—just 0.02% of the records received. Democrats posted four photos related to President Trump and again made targeted redactions:



In two photos, Democrats censored adult women's faces to smear President Trump. Congresswoman Yassamin Ansari even posted on X:



One of the unredacted photos shows President Trump standing next to adult Hawaiian Tropic women models.

According to [The Telegraph](#), one woman pictured in the image said he was a “gentleman” who went out of his way to make sure the group enjoyed their evening at Mar-a-Lago.

Democrats also posted an image—stripped entirely of context—of a novelty condom featuring Donald Trump’s face and the phrase “I’m HUUUUGE!” In reality, the item is political satire displayed by the [Smithsonian’s National Museum of American History](#). According to the museum’s website, “[t]he package features a cartoon image of 2016 Republican presidential candidate Donald Trump. The text reads ‘I’m HUUUUGE!’ which plays on Trump’s pattern of speech and use of catch phrases; the front of the package also reads, ‘Say it with a condom.’”

The packaging was designed by Fishs Eddy, a New York City-based housewares and novelty shop. The reverse side displays the Fishs Eddy name along with a link to [sayitwithacondom.com](#), a website where consumers can order custom condoms featuring topical slogans or designs.



III. Democrats Tout “Never-Before-Seen” Epstein Island Photos — But They Were Released Months Earlier

On December 3, 2025, Oversight Committee Democrats posted images on X of Epstein Island that were obtained through the Majority’s [request](#) to U.S. Virgin Islands Attorney General Gordon Rhea. Democrats sensationalized the release by claiming the photos were “never-before-seen.”



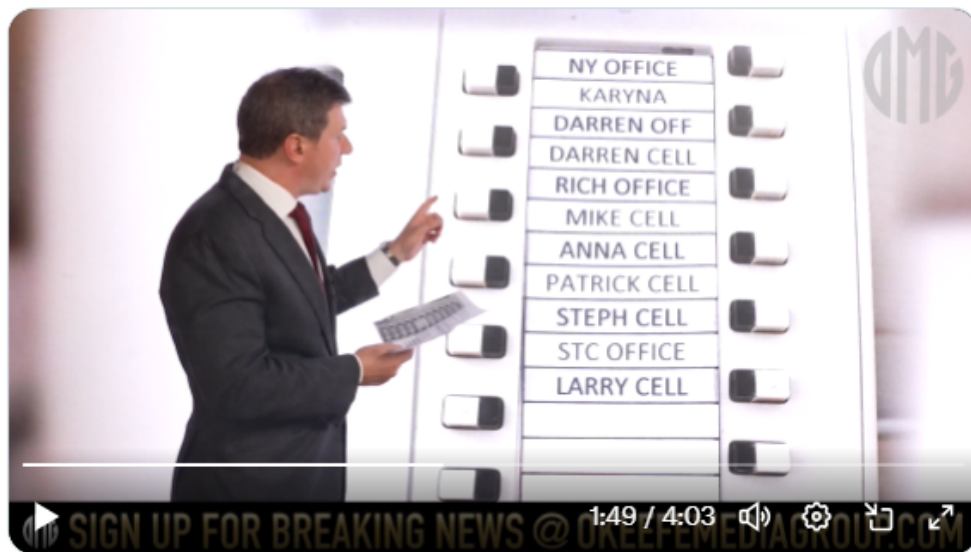
Legacy media quickly echoed Democrats’ narrative.

IV. Conclusion

Throughout the Oversight Committee’s review of the federal government’s handling of the Epstein and Maxwell criminal investigations, Democrats have demonstrated a sustained pattern of misconduct—misrepresenting witness testimony, selectively leaking cherry-picked documents, and manipulating emails and images—to fabricate yet another politically motivated hoax targeting President Trump.
